DASMA's legal counsel, Nathan J. Breen, dies at 49

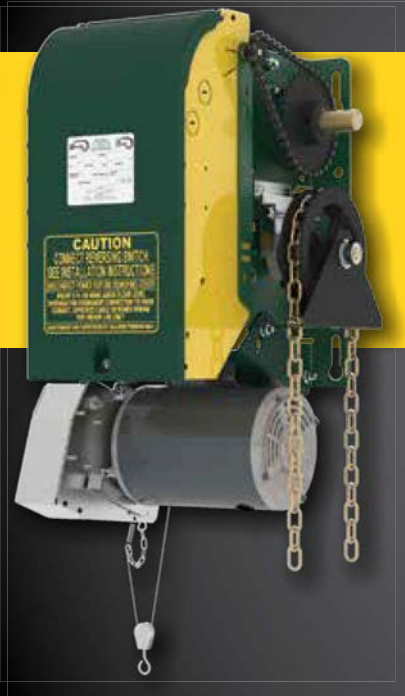
