

Milestones

- 1969 In Drummondville, Quebec, Roger Dubois and two partners found Canimex, a company that imports and exports bearings and oil seals, chains, sprockets, and other mechanical components.
- 1980 Michel Beaudoin makes his debut with Canimex as a sales representative for the Mechanical division.
- 1981 Canimex gains its first customer in the garage door industry.
- 1985 Canimex launches its chain hoist production line.
- 1987 The Hydraulic division is created.
Canimex acquires the Torque Force trademark and begins the aluminum die-cast production.
- 1988 The Torque Force division is founded.
- 1991 Canimex hires Ron Clark, the first Torque Force sales representative in the United States.
- 1993 Roger Dubois becomes the sole owner of Canimex.
- 1995 Canimex acquires a new 70,000-sq.-ft. warehouse for the aluminum die-cast production.
- 1997 The Torque Force division develops its innovative Torque Balance software, a program that calculates the correct springs to counterbalance any sectional garage door.
- 1998 Canimex extends the Torque Force manufacturing plant in Drummondville to 175,000 sq. ft. and establishes its first warehouse in the United States in Orlando, Fla.
- 2000 Canimex extends its warehousing capacity in Drummondville with the acquisition of a new 100,000-sq.-ft. warehouse and manufacturing plant.
The Clever Plugs product line is created by the Torque Force division.
- 2001 Canimex renovates its head office in Drummondville, increasing it to 130,000 sq. ft.
Michel Beaudoin becomes division director for Torque Force.
Canimex acquires Drummondville-based OPD (112,000 sq. ft.), a company specialized in stamping, sheet metal works, and mechanically welded parts.
- 2002 The Torque Force division obtains the ISO 9001-2000 certification.
- 2003 Canimex Torque Force introduces its Spring Break Device for residential doors, designed to reduce the risk of a door falling due to a spring breakage.
- 2004 Canimex acquires Drummondville-based Logimex (40,000 sq. ft.), an importer and distributor of household appliance components, and Arpex (45,000 sq. ft.), a designer and manufacturer of thermoforming molds and stamping dies, also in Drummondville.
The Torque Force division introduces the Stopping Bottom Bracket V2i (SBB V2i), designed to reduce the risk of a door from falling in the event of a cable failure.
- 2005 Canimex acquires Manaras-Opera (43,000 sq. ft.) in Pointe-Claire, Quebec, a company that designs, assembles, and markets operators for commercial and industrial garage doors, grilles, and shutters.
- 2006 Canimex acquires a new 700,000-sq.-ft. warehouse and manufacturing plant in Drummondville.
The Torque Force division introduces the Canimex Governor Device for manually operated rolling steel fire doors.
- 2007 Canimex Torque Force introduces the SBB V3 featuring a burglar-resistant device, extending its offering of free-fall containment devices.
- 2008 Canimex launches a completely new Web site at www.canimex.com.
Canimex Torque Force starts selling directly in Europe after 20 years of presence through a European distributor and opens four warehouses and distribution points in Europe.
- 2009 More than 850 employees now work for Canimex. The Torque Force division has 12 warehouses and distribution points in North America.
