# **GARAGA ACQUIRES MID-AMERICA DOOR** First-ever acquisition of a U.S. garage door maker by a Canadian door firm



n August, Garaga of Saint-Georges, Quebec, announced that it had purchased Mid-America Door of Ponca City, Okla. The acquisition appears to be the first time that a Canadian garage door manufacturer has bought a U.S. garage door manufacturer.

#### **Bigger footprint in the U.S.**

The move will significantly increase Garaga's footprint in the United States, expanding its market to dealers in 40 states.

"Mid-America's geographic location is perfectly complementary with ours. Garaga's customers are located in New England and the northern tier of the USA, whereas Mid-America's customers are located mostly in the southern tier of the USA," said Maxime Gendreau, who is copresident of Garaga with his twin brother, Martin Gendreau.

The Gendreau twins, who were essentially born into the garage door business, are 34 years old. In the past 20 years, they have worked in all company departments and are now ready to take on an acquisition. "We felt that the best way to bring our U.S. business to the next level was to make an acquisition," said Maxime.

### **Complementary product lines**

Both Garaga and Mid-America Door manufacture residential and commercial sectional garage doors. Garaga specializes in polyurethane-insulated doors, whereas Mid-America Door provides its dealers pan and polystyrene-insulated garage doors.

Consequently, the Mid-America product line "perfectly complements our offering to the market," said Gendreau. He noted that Garaga will consider adding a polyurethane product within the Mid-America product line.

Garaga plans to develop both brands and grow their respective product lines so that both distribution networks will be able to offer a more complete offering. "Our product lines are complementary, so we intend to leverage each other's strengths to the benefit of our dealers," he added.

### **Merging cultures**

"We are excited about the opportunities this transaction brings, as we will combine our expertise to better serve each of our dealer networks," added Martin Gendreau, copresident of Garaga.

"After working on this acquisition, we find there is a great culture fit between our two businesses," he added. "We will rely on the current Mid-America team to continue to do what they do well, providing consistent excellent quality and service to their dealer network."

### **Earnest to retire**

Industry veteran John Earnest, current president of Mid-America, will retire from day to day operations. "I am very excited to have Garaga acquire our business, as I believe they are the best possible fit for us," he said. "Both our employees and dealer base will gain from this transaction."

Carl Christensen, current vice president and COO, will become the general manager of Mid-America Door, while Brandon Rutz will be director of manufacturing and Mike Schoen will be director of sales and marketing.

- **2012** After a tornado destroys one of the company's two plants in 2011, the main building is expanded by 80,000 sq. ft.
