

## Ray Neisewander Jr., Industry Leader, Dies at 81

(See complete story on page 40.) On Oct. 25, Ray Neisewander Jr., the chairman of the board of Raynor Worldwide, died at his home in Dixon, Ill., after a long illness. He was 81.

He began his garage door career in 1956 when he started a Raynor dealership in Bettendorf, Iowa. In 1961, he moved to Raynor headquarters in Dixon, Ill., and worked in many aspects of the company's operations in the factory and office.

In 1979, he became the president, CEO, and chairman of the board for Raynor as well as the Kwik-Wall Company and Raynor Hotel Corporation of Springfield, Ill. Under his leadership, Raynor sales grew from \$30 million in 1979 to more than \$100 million in 2000.

In 1972, he was elected to the board of directors of the National Association of Garage Door Manufacturers (NAGDM). He served as NAGDM president from 1973 to 1974 and as treasurer from 1986 to 1996. He remained on the DASMA board of directors until 2000.

In 2004, he became Raynor's chairman of the board. In 2006, the International Door Association named him as the recipient of the industry's first Heritage Award for outstanding contributions to the garage door industry. ■


